Prior to assuming your duties, an Oath of Office **must be** administered by the Clerk of Circuit Court or her designee, with a copy of administered oath returned to the City Clerk's Office. If not selected, your application will remain on file in the City Clerk's Office for one year from the date of application, for consideration of future vacancies.
